Firms employing more than three professionals serving health care clients (law firms, executive search firms, and consulting firms). Pre- and post-acute health care organizations, including home health, skilled nursing facilities, and hospice providers. Annual Dues: \$2,000

## Corporate/Health Care Supplier/Provider

Information systems, technological services, manufacturers, managed care organizations, equipment and pharmaceutical companies and other suppliers. Pre- and post-acute health care organizations, including home health, skilled nursing facilities, and hospice providers. Annual Dues: \$3,000
